HAWA CLIPO 16 HM IS is a top running sliding system for two wooden doors weighing up to 35 lb (16 kg) each, for inslide/inlay applications. The running gear is mortised/rebated into the top of the door. There are different top track options for single and double track applications that can be recessed or surface mounted to the cabinet top. An optional soft-close mechanism (sold separately) is available for inside the track. The bottom of the cabinet does not require a lower guide track in the base.

- High-tech, invisible soft closing system integrated into the running track. - Easy door installation, with clip-on system. - More closing convenience: doors close softly and are pulled into the final position. - Central stopper prevents doors from crossing.
